## Highlights of the 2018 Financial Report Canton de Melbourne



## Dear taxpayers and citizens,

In accordance with article 176.2.2 of the Municipal Code of Québec, and in order to ensure a greater transparency of the municipal administration, I am proud to present the highlights of the 2018 financial report of the Canton de Melbourne.

The consolidated financial statements as at December 31, 2018, were tabled at the regular council meeting on April 1<sup>st</sup>, 2019. The consolidated financial statements and the summary of financial information are available at the municipal office at 1257 route 243, Canton de Melbourne, and can be consulted during regular office hours.

## The Financial Report

The financial statements as at December 31, 2018 show operating revenues of 1 823 673 \$ and investment income of 365 261 \$ (grants), which generated total revenues of 2 188 934 \$ for this fiscal year. The various expenses of the municipality totaled 1 753 258 \$. Taking into account the various items of conciliation for tax purposes (investment income, depreciation, appropriations, etc.), the 2018 financial statements show a surplus of 339 981 \$.

#### **External Auditor's Report**

The firm, Raymond Chabot Grant Thornton, auditors of the Municipality, certify that the consolidated financial statements present fairly, in accordance with the Canadian Public Sector Accounting Standards, the financial position of the Canton de Melbourne for the fiscal year concerned.

#### Remuneration of the elected municipal officers

In accordance with article 11 of the Act respecting the remuneration of elected municipal officers, the municipality's financial report must contain a reference to the remuneration and expenses allowance that each member of the council receives from the municipality, a mandatary body of the municipality or a supramunicipal body.

The remuneration of elected officials of the Canton de Melbourne in 2017 was as follows:

Councillors	3 092 \$	allowance	1 546 \$	Total	4 638 \$

In addition, the Mayor received a remuneration of 1 162 \$ and an expense allowance of 581 \$ as a member of the MRC du Val-Saint-François. The Pro-Mayor received a remuneration of 259 \$ and an expense allowance of 129 \$ as a member of the MRC du Val-Saint-François.

In addition, each member of the municipal council received an additional remuneration of 50 \$ as well as an expense allowance of 25 \$ for each committee meeting of which he was a member and attended.
